2. The map submitted by the User Agency has not been authenticated by the Tahasildar concerned.
3. The resolution of Ama Sabha of Grampanchayat has not been furnished.
4. Certificate from Collector, Khordha under Forest Right Act, 2006 has not been furnished.
5. The cost benefit analysis has not been furnished in the prescribed proforma.
6. Environmental clearance has not been furnished.
7. The page No. of the Annexure have not been mentioned in the check list..
8. The compensatory Afforestation scheme has not been submitted with the Project Proposal.
9. Enumeration list of tree growth on Forest/Non Forest/ Private land duly authenticated by all concerned has not been submitted with the Project Proposal.


After receipt of your compliance report further necessary action shall be taken at this end.
