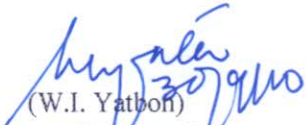
Please refer to the State Government's letter in the reference on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. The proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder and found incomplete. The following are the additional lacking information:-

1. The aerial distance of the proposed area from the nearest WLS/PA/NP.
2. The scheme for raising avenue plantation on both side of the road technically approved by the competent authority.
3. The muck disposal plan along with the muck dumping sites with GPS coordinations mentioning about quantity of muck to be generated and to be dumped.
4. The current status of F(R)Act, 2006
5. The GPS coordinates of the proposed road along with the starting and end point of the road.

6. The ROW width of the proposed road.
7. The soft copy of the Shape/kml file of the proposed area and CA site.
8. Undertaking certificate for payment of CA

State Govt is requested to kindly furnish the above requisite information to this office for further processing of this proposal.

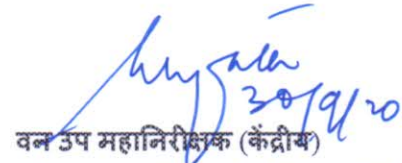
