Submission of diversion proposal for improvement of road and CD works from
Patdhara to Kathafar under PMGSY scheme.

Sir,


With reference to the above cited subject, you are requested to comply the following deficiencies and submit the diversion proposal in quadruplicate to this office at an early date for onwards transmission to the higher authorities.

1. A copy of De-Reservation Proposal (DRP) in hard copy alongwith all connected documents should be submitted to this office.
2. You should submit the hard copy of Part 1 of Form-A of online application.
3. Copy of the Sanctioned order of the project should be submitted to this office.
4. Status of forest land as on 25.10.1980 duly authenticated by the concerned Tahasildar should be provided.
5. FRA certificate in prescribed format for linear project issued by the Collector should be provided.
6. You are asked to report whether take up any widening of the proposed road or not.
7. You should submit the Lay out plan of Project site.
8. You should submit the Certificate that no alternative suitable non forest land is available for the project in question and that this is the best location from among several alternatives considered and involving the barest minimum extent of forest land.
9. You should submit the Certificate for minimum use of forest land.
10. You should submit the Cost benefit analysis as per the guidelines issued under Forest (Conservation) Act, 1980 in prescribed format. If not required reason may be mentioned.
11. You should submit the undertaking to bear the cost of compensatory afforestation.
12. You should submit the Undertaking to pay the Net Present Value (NPV) of the forest land involved.
13. You should submit the Details of non forest land/degraded forest area identified for compensatory afforestation viz. Survey No., Compact No., Village, Tahasil, District etc. alongwith the boundaries of adjoining areas with their land use in district colours.

14. You should submit the detailed scheme for compensatory afforestation on identified non forest area/ degraded forest area at present wage rates duly signed by the DFO and countersigned by the C.F concerned. The C.A.Scheme must includes all the technical details, details of work schedule, total financial outlay and proposed monitoring mechanism.
15. You should submit the certificate from the DFO that non forest land selected for compensatory afforestation is in a compact block and contiguous to forest area or in close proximity of forest area and suitable from the management and protection point of view.
16. You should intimate the length & width of the Road passing through Forest and Non Forest area.
17. Length of Road already existing constructed out of the total length involved in the project proposal.
18. Does it involve a new alignment in forest area?
19. Does the project involve widening or black topping of existing formation?
