Polytechnic Jandaur in Tehsil Jaswan Distt. Kangra HP within the jurisdiction of Dehra Forest Division, Distt. Kangra, Himachal Pradesh.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.9918 हेक्टेयर वन भूमि की मांग की गई है।

2. राज्य सरकार द्वारा इस कार्यालय के समसंख्यक पत्र दिनांक 20.01.2025 के अनुपालन में भेजा गया स्पष्टिकरण पूरी तरह से स्पष्ट नहीं है, अतः प्रस्ताव से सम्बंधित जानकारी भेजने का कष्ट करे:

- 1. In reference to observation No-1**, detailed justification of the proposal to ascertain the legitimacy of the project as site specific or non-site specific was sought from the State Govt. However, State Govt has submitted the layout plan instead of submitting the detailed justification of the proposal. Therefore, State Govt is required to submit the detailed Justification, In view of the guideline dated 24.09.2024, to ascertain the legitimacy of the project as site specific or non-site specific.
- 2. In reference to observation No-2, REPLY NOT ACCEPTED**, clarification was sought from the State Govt to mark the alternatives and submit along with reason for their rejection/acceptance. In this regards, State Govt has submitted the reason for the acceptance and rejection of the alternatives however same not found marked on the KML. Therefore, State Govt shall mark all the alternatives in the KML in distinct colours.
- 3. As per the Aerial distance certificates uploaded at (S.No-3)-Part-I & (S.no-4)-Part-II**, distance of the proposed site from the boundary of WLS varies from 5km to 6.91 km. As per the aerial distance certificate "boundary of Pong Dam wildlife is about 5 or 6.91 Km from the proposed site construction of Govt. Polytechnic Jandour at Mouza Kotla Mohal Jandour Tehsil Jaswan Distt. Kangra H.P within the jurisdiction of Dehra Forest Division". Since the ESZ of the pong Dam WLS has not been declared yet, then the (ESZ of a Protected Area is not notified, then,10kms distance from boundary of the Protected Area should be treated as ESZ). Therefore, State Govt is required to submit the specific comments of CWLW wrt any adverse impact on PA and the resident wildlife therein due to instant proposal along with mitigation measures thereof, if any.
