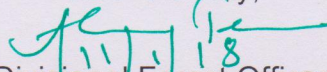

It is to inform that, in the reference 1st cited, the Prl. Chief Conservator of Forests (HoFF) A.P. Guntur has communicated proposals in hard copies for diversion of 4.76 ha of forest land for formation and BT to the road including construction of culverts from ZPP road to Dhanasanivalasa (V) of Araku Valley (M) through Lotheru RF Compt.no.469, 470, 471 & 472 in Visakhapatnam Division in favour of Executive Engineer, Panchayat Raj (PIU) Paderu. The same was communicated to Forest Range Officer, Ananthagiri for verification in the reference 2nd cited.

In the reference 3rd cited, the Forest Range Officer, Ananthagiri has submitted a report that the road from ZPP road (Lotheru) to Dhanasanivalasa after verification the area comes to 2.8087 ha. instead of 4.76 ha. which is deviation is noticed. Hence the Executive Engineer, Panchayat Raj (PIU) Division, Paderu is requested to contact the Forest Range Officer, Ananthagiri and depute concerned responsible persons for conducting joint survey for the above aforesaid said road and contact Forest Range Officer, Ananthagiri for survey.
