- (iii) Comments from CWL as proposed area for diversion falls under ESZ of Jiri Makru WLS.
- (iv) Length of existing road.
- (v) Proposed two-lane of Mandeu-Jiri River Section is from Km 80.630 to Km 96.870; What is the status of up-gradation prior to and after Km 80.630 to Km 96.870.

The above additional information may be furnished at the earliest so as to enable this office for discussion in the next REC.
