The CCF, Adilabad in the ref 6th cited has submitted point-wise replies to the EDS raised by the MoEF&CC, Gol, Hyderabad vide ref 4th cited.

In reply to the EDS point 4, the District R&B Officer, Kumaram Bheem- Asifabad District has informed that the revised revised map, .kml file for 1.419 ha of non-forest CA land uploaded in the online application.

As verified from the online portal against the subject projects, **revised maps and .kml files of 1.419 ha non-forest CA land are not uploaded by the User Agency in the portal.**

In view of the above, the District R&B Officer, Kumaram Bheem- Asifabad District is requested to take immediate necessary action in uploading replies on EDS point-4 and other relevant documents in the Ministry's portal and submit the same to this office for taking further necessary action in the matter.

It may also please be noted that further action including permission from the Competent Authority is linked with the submission of compliance of EDS raised above from the office of the RO Hyderabad hence this may be treated on top priority for expeditious clearance.
