Sub: Proposal for diversion of 14.742 ha of forest land for construction of 132 KV Link Transmission Line for evacuation of power from 400/132 KV sub station at Thoubal to 132 KV Sub-Station at Kongba, Yainhangpokpi and Hundung on existing 132 KV line from Kongba to Kakching on turnkey basis in favour of Manipur State Power Company Ltd.

Sir,

With reference to the subject and letter cited above, I am directed to inform that the proposal submitted has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The submitted proposal is found lacking of the following information:

- (i) The proposed Right of Way of the proposed Transmission
- (ii) The 3D diagrammatic sketch of the proposed transmission line showing the nos. of the tower and the Right of Way.
- (iii) The GPS coordinates and photographs of the sample plot for the tree enumeration showing trees marked in field and serially numbered with red/yellow paint.
- (iv) To provide the corrected soft copy of the shape/kml file of the proposed diversion as the area of the submitted shape file i.e. 25.692 ha is different from the proposed area i.e. 14.742 ha.
- (v) The soft copy of the shape/kml file of the proposed compensatory afforestation area in polygon feature.
- (vi) The GPS co-ordinates of the proposed Transmission Line.
- (vii) The photographs along with GPS co-ordinates showing the site inspection conducted by the concerned DFO/CF of the proposed transmission line and compensatory afforestation sites.
- (viii) The undertaking by the user agency for the payment of the Addl. NPV.
- (ix) The Compartment No. of the proposed diversion site.

State Govt is requested to kindly furnish the above mentioned additional information to this office at the earliest for further processing of this proposal.
