On scrutiny of the above mentioned forest diversion proposal pertaining to Sundargarh Division, the following shortcomings were noticed.

- I. The FRA certificate has not been furnished in the DP by the User Agency.
- II. The list of non-forest land has not been signed by the User Agency. The detail statement of applied non-forest land has not been furnished in the DP.
- III. The User Agency has not shown the three alternative alignments of transmission line in the Topo Map along with a comparative statement.
- IV. Proper Shape file and KML file for CA land is wanting.

You are requested to submit the compliance within 3 days positively so as to enable this office to process the proposal.
