8. Demand letter of the competent authority is not attached with the proposal folder.


9. From the perusal of KML file, the proposed road and one dumping site is coming in Shree Naina Devi Ji wild life protected area which is required to clarify.
10. The road is constructed in violation FCA 1980 as such the joint inspection of committee constituted vide judgment of the Hon'ble court of Himachal Pradesh in CWP No. 5600 of 2012 dated September 05, 2013 titled "Sh. Manoj Kumar S/o Sh. Shiv Charan Vs UOI and others" linked the COPC No. 56 of 2009 is required.

You are therefore requested to attend all observations and send complete case for onward transmission to higher ups.
