Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of **2.895** ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the above-mentioned proposal of the Govt of J&K the following information/clarification are still required to be submitted:

- (i) Area mentioned in CF's recommendations is erroneous i.e. 2.89 ha while the proposal is submitted for 2.895 ha. Need to be corrected.
- (ii) IAs per TA (DSS) the proposed project site KML area is 1.43 ha. Instead of 2.895 ha. Also DGPS map to be revised as Lat/Long is not provided in the given DGPS map. Need to revise CA site DGPS map pdf because Lat/Long are missing from the uploaded document.
- (iii) Perusal of KML reveals that the dumping yard no. 4 is located in heavily dense forest area. so UA need to revise the dumping site 4 if possible to some another place so that minimum no. of trees to be felled.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
