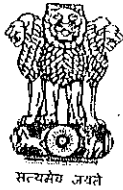

Sub.: Exit/Entry and Middle Approach of Proposed Essar Oil Limited Retail Outlet on Shahabad-Hardoi Road, (SH-25) on khasra no. 200 between km 135 to km 136 on left side for proposed protected forest diversion of 0.065348 ha with felling of 8 trees-reg.

Sir,

In reference to your above mentioned letter where approval for above referred proposal was sought; I have been directed to convey following shortcomings of the proposal for necessary rectification:

1. The proposal mentions requirement of non forest land as NIL which is incorrect and needs correction in part I of the proposal.
2. The kml file uploaded with the proposal shows presence of trees on proposed forest land diversion whereas the proposal is without felling of trees. This needs explanation.
3. The geo referenced map of the proposal has provided geo coordinates for few points. The required geo co ordinates to define curvilinear portion of the entry & exit has not been provided.
4. The certificate provided under FRA 2006 (uploaded with the proposal) is without date and dispatch number.
5. The copy of forest land gazette notification (uploaded and hard copy) is not legible and therefore needs submission of legible copy.
6. At page 18 of the proposal regarding enumeration of trees falling within proposed forest land is 8 (eight) in nos whereas in uploaded part II number of trees are NIL. This discrepancy needs correction.
7. The compensatory afforestation scheme at page 26 is for plantation of 100 saplings and as per online uploaded scheme the same is for planting of 261 saplings on DDFL (Double Degraded Forest Land). Issue needs revision and as per guidelines of FCA 1980.



8. The site inspection report of DFO at page 31 mentions existence of rare/ endangered/unique species details enclosed but the same is not found with the proposal. Part II of the proposal contradicts this fact. This issue needs rectification.

Therefore, the original proposal is hereby returned for rectification/revision of the proposal as per the observations made in a point wise manner.
