Subject: Diversion of 2.178 hectare of forest land in favour of HPPWD for the construction of link road from Panyala to Tiun Khas Km 0/0 to 5/500 within the jurisdiction of Bilaspur Forest Division.

Please refer to your office letter No. PW/GHD/CB/WA/Forest Case/2017/19051-53 dated 28.03.2017 on the subject cited above.

From the perusal of proposal folders received vide your office letter under reference, the following shortcomings have been noticed:

1. Against column C(iii), although a map on toposheet has been uploaded but there is no heading has been mentioned on the toposheet. Revised map with proper heading and index is required to be uploaded.
2. The location of beneficiary villages along with the existing road network in area may also be marked in the KML file/digital map submitted online at Para C (ii) (b) with the proposal.
3. The enumeration list/abstract of trees proposed to be felled is required to be submitted in species- wise with local/scientific names in dia-class in the following format:-

5. As per old proposal, there was violation of FCA, 1980 in this case but in fresh proposal folder there is no document placed about the violation. In case the present road is constructed in violation of FCA, 1980 then extent of violation, name of authority which is responsible for violation may be intimated along with detailed note on violation. It may also be intimated as to whether this road is included in the list 2183 case or otherwise. Beside this as per old folder Joint inspection report of committee dated 04 April 2014 headed by CF Bilaspur was placed folder which require afresh.
6. KML file of the area proposed for diversion may also be provided in shape of CD/Pen Drive.

7. Against column E(iii) online, employment likely to be generated has been shown 65000 whereas, in part-I hard copy 29792 mandays are likely to be generated. Please clarify
8. Total period for which the forest land is proposed to be diverted is 999 mentioned in online Part-I. Please clarify

You are, therefore requested to attend the aforementioned observations and re-submit the proposal folders after doing the needful. Further, you are also requested that in future before submission of proposal folders, depute dealing hand of your office to get the proposal folders scrutinized in this office.
