महोदय.

उपरोक्त विषय पर सन्दर्भित पत्र का आशय ग्रहण करते हुए प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी है। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें, तािक अग्रिम कार्यवाही सुनिश्चित की जा सके:—

- 1. As per DSS analysis of KML file of CA area, 18.60 ha area found uploaded instead of 19.082 ha. Further, 07.00 ha area found in MDF. State Government may submit/upload plantation scheme as per guidelines dt. 08/11/2017.
- 2. Details of area mentioned in SoI toposheet and digital map uploaded online found incorrect. However, submitted correct documents in hard copy. State Government may upload the SoI toposheet and digital map mentioning correct area.
- 3. It is seen that date is not mentioned in the FRA certificate of District Magistrate and area is mentioned as 2.275 ha instead of 9.541 ha. Further, it is seen that few corrections have been made in the Sub-Divisional level Committee (SDLC) meeting proceedings. State Government may submit the correct FRA certificate with date mentioning the correct area and also submit the SDLC meeting proceedings after countersigning the corrections made in it.
- 4. It is seen that the hard copy of the proposal contains coloured scan copy of all the documents. State Government may submit the hard copy of the proposal original copies of all the documents.

- 5. Following corrections/ documents/ information are required to be uploaded/ submitted by DFO:
  - a. Number of trees mentioned to be affected are 406 and all in RF area. State Government may clarify number of trees in 5.496 ha Civil soyam land. It is also submitted in one document submitted with the hard copy that the total number of trees are 370 out of which only 273 will be felled.
  - b. 'NIL' has been mentioned against para 5 i.e. "Working plan prescription for the forest land proposed for diversion", in online Part II.
  - c. Nothing has been mentioned against para 7 i.e. "Approximate distance of the proposed site for diversion from boundary of forest (in km.)", in online Part II.
  - d. District profile details filled at para 14, Part II seems incorrect.
  - e. No comments have been made by the DFO in Site Inspection Report against all paras.
- 6. In para-A-2 (i), name of User Agency is mentioned as Executive Engineer, Irrigation Division, PMGSY instead of Rural Development Department (Gramya Vikas Vibhag). State Government may mention the correct name of User Agency at para-A-2, Part I.
- 7. In the document uploaded at S. No. 01 of the additional document, Part I, it is mentioned that the total length of the road is 13.00 km and land transfer for 3.00 km has already been done but the details of the past proposal has not been provided in the table at para B-1, Part I. State Government may provide the detail the detail of past proposal at para B-1. Part I online.
- 8. It is seen from the copy of map indicating location of alternative alignment goes all along the proposed alignment which seems mere formality done by the project proponent. State Government may explore alternative alignment form right bank of Ganga River involving less distance.
- 9. In para 1 (i) (A) of Part I, it is mentioned that the project is not located within the protected area which contradicts the remarks given in para 8 (ii) of Part II. State Government may submit clarification in this regard.
- 10. The land for CA has been indentified in Kota civil soyam (12.512 ha) and Mala civil soyam (6.57 ha) but complete details has not been filled up in para-L (iv) of Part I and para-13 of Part II in respect of both the patches. State Government may provide complete detail of CA area at para L of Part I and para-13 of Part II.
- 11. इसके अतिरिक्त, मलवा निस्तारण हेतु Reserve Forest क्षेत्र का चयन किया गया है जो मान्य नहीं है। अतः राज्य सरकार मलवा निस्तारण हेतु अन्य क्षेत्र का चयन करना सुनिश्चित करें।

यदि चाही गई सूचना पत्र जारी होने की तिथि के 60 दिनों के भीतर (अधिकतम 90 दिन) इस कार्यालय में प्राप्त नहीं हुयी तो प्रस्ताव को निरस्त किया जा सकता है।
