The undersigned is directed to refer Government of Maharashtra letter No. FLD-2021/C.R.176/F-10 dated 25.09.2021 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/NODAL/Gadchiroli/ID-12856/1034/21-22 dated 22.09.2021 and APCCF & Nodal Officer (FCA), Maharashtra letter No. Desk-17/Nodal/Gadchiroli/ID-12856/1656/2021-22 dated 01.12.2021 forwarding additional information as sought vide this office letter of even number dated 29.10.2021. After detailed discussion and examination of the proposal and recommendation of State Government the Committee decided to approve the proposal. The Committee further decided that IRO, Nagpur shall issue approval only after the receipt of comments of the PCCF, Wildlife regarding any possible adverse impact and mitigation measures thereof with respect to proposed road.

In view of the above, I am directed to request the State Government to submit information on the shortcomings, as indicated above, to this Ministry for further consideration of the proposal for approval under the Forest (Conservation) Act, 1980.
