Please refer to the State Government letter F. No. FRS.260/2018/39 dated 21.12.2018 on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The following additional information/documents are found lacking:-

- 1) To submit the complete information on the Sl.No. 10 of the forwarding letter of State Govt letter mentioned under reference above as the same has not been filled up.
- 2) The aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Parks.
- 3) The status of Environment clearance.
- 4) Undertaking certificate by the user agency for the payment of compensatory afforestation.
- 5) The original copy of the C.A. scheme technically approved and duly signed by the competent authority.

- 6) To provide the legible copy of the no objection certificate of the villager for the proposed CA as the submitted letter is not readable.
- The land record for offering the proposed CA site in non-forest land, to ascertain the legal status of land.
- 8) To clarify the requirement of the approach road to the proposed area.
