It is informed that, in the reference 3rd cited, (6) sets of hard copies of proposals for diversion of 4.92 ha. of forest land falling in compt. no.141,142,143,144,149,150 & 151 in Vizianagaram Division for improvement of Kurupam – Muliguda road to Beerupadu in f/o EE R&B Division, Parvathipuram was sent to Divisional Forest Officer, Vizianagaram and Conservator of Forests, Visakhapatnam and requested to process the proposal for getting clearance under Forest(Conservation) Act, 1980 and amendments therein.

Accordingly, the proposal was processed and recommended by the Divisional Forest Officer, Vizianagaram and Conservator of Forests, Visakhapatnam and the same was received in the reference 4th cited. On verification of the proposal, the following shortcomings are noticed.

- The authenticated map sheets are torn and also not countersigned by the field officers of the concerned division. Hence to be rectified.
- The Divisional Forest Officer, Vizianagaram in Part -II and in field inspection notes, has stated that, the road is passing in Deruwada RF with a length of 2410 m. in compt. no.150 & 151, Thatchidi RF with a length of 1280 m. in compt nos.146 & 149 and Goipaka RF with a length of 4510 m. in compt. no.141,142,143 & 144. But in the authenticated map, compt. no.141,142,143,144,149, 150 & 151 only were shown excluding compt. no. 146.

Hence, the proposals received in the reference 4th cited are returned herewith. The Conservator of Forests, Visakhapatnam is requested to re-submit the proposals duly rectifying the above shortcomings for taking further action in the matter.
