It is informed that, the Prl. Chief Conservator of Forests, Andhra Pradesh, Guntur has forwarded the proposals furnished by the Superintendent Engineer, TGP & GNSS Circle, Tirupati through reference cited above for diversion of Forest Land to an extent of 740.885 Ha of Forest Land in Karakambadi RF, Adavaram RF, Ramapuram RF and Nagalapuram RF for Alignment of bund, Foreshore submersion and Canals for Sri Balaji Reservoir, Mallemadugu Reservoir and Kailasagiri Canal in Chittoor District under GNSS Phase-II Project. The proposals received are verified and notice the following omissions and commissions.

- 1. The proposals in 6 sets hard copies in full shape are not furnished.
- 2. The Forest area required for diversion by the user agency are falling within the eco-sensitive zone. Hence the user agency should submit Environmental Management Plan along with the proposals.
- 3. The digital maps with Geo-co-ordinates furnished by the user agency are not authenticated. Therefore, the digital maps furnished, both for Diversion of Forest Land and Raising of CA on Non-Forest land shall be verified by the geomatics center at Prl. Chief Conservator of Forests office, Andhra Pradesh, Guntur.
- 4. Soft copy of the entire proposals in the PDF format are not furnished.
- 5. Original map on Survey of India Topo sheet on 1:50,000 scale, of the project, showing the location of the area proposed for diversion passing / covering through Reserved Forest Area duly indexed to be furnished.
- 6. Details of Forest area required, compartment wise in each forest block is to be furnished clearly in the proposals.
- 7. Purpose wise break up of the project for which forest land required is to be furnished clearly. (The break up furnished in the Survey of India Topo sheet and proposals in Proforma A of Part-I are not being tallied).
- 8. Statement showing the details of non forestry activities involved in the proposals should be furnished.

- 9. Cost benefit analysis should be furnished in detail as per the guidelines communicated by the Government of India.
- Under taking by the user agency to pay the Additional Net Present Value (If levied) of the Forest land involved.
- 11. Make and model of the DGPS equipment used along with name of the agency to be furnished.
- 12. Certificate from the Divisional Forest Officer concerned that the non forest land selected for CA is in a compact block and contiguous to forest area or in close proximity of Forest area and suitable from the management and protection point of view.
- 13. Soils suitability certificate from Divisional Forest Officer that the area identified for CA is suitable for raising plantation.
- 14. Catchment Area Treatment Plan (CAT Plan) if applicable is to be furnished.
- 15. Certified that, the peg marking on ground is completed at the following different levels of Reservoirs is to be furnished.
 - a. Full Reservoir level (FRL)
 - b. Below 2 Mts of Full Reservoir level (FRL)
 - c. Below 4 Mts of Full Reservoir level (FRL)

The above omissions and commissions as noticed by this office may please be attend at the earliest so as to take further action in processing the proposals.
