In this connection, attention is once again invited to the EDS query raised by the Government and the user agency may be informed to obtain the certificate in the format prescribed by the Government of India in F. No.11-9/98-FC (Pt), dated 05.07.2013 (Hand book of Forest Conservation Act 1980 published during March - 2019) on completion of process for settlement of rights under Forest Rights Act 2006 on the forest land proposed for diversion with full name and official seal of the District Collector in the certificate and upload the same under Section K of Part-I of Form-A in the web portal and furnish the original hard copy of the certificate in duplicate to this Office early.


