
Memo, Please refer to your office Memo. No. 4700 dated 29.07.2020 on the subject cited above.

2 Following shortcomings have been noticed in the proposal in online Part-I & II as well as in hard copy of the proposal folder:-

1. Page Numbers have not been mentioned in the Checklist as placed in the proposal folders.
2. Demand letter has been placed in the proposal folder from page No. 8 to 11 but in the checklist demand letter has been shown placed at page No. 1 to 7.
3. Map on toposheet as uploaded against column No. C(iii) is not found placed in the proposal folders.
4. Details of alternative alignments have also been included in layout plan as per Sr. No. 6 of Checklist. Paging should be done correctly and different documents should be placed in the proposal folder at different pages with correct numbering.
5. Legal status of the forest land proposed for diversion has been mentioned as protected forest in Part-II but at Checklist No. 7 in the details of forest area proposed for diversion, the legal status of forest land has been mentioned as Shamlat Baloti. The correct status of land may be mentioned in documents.
6. However, the certificate for minimum use of forest land has been placed in the proposal folder at page No. 41 but the details of the area and trees involved in the alternatives examined and reasons for their rejection duly authenticated by DFO concerned has not been attached with the certificate.
7. Abstract of the trees is not found correct as placed in the proposal folder at page No. 45 & 46. Enumeration list of the saplings i.e. 28 (Saplings of Khair 24 + Saplings of Shisham trees 4) has not been submitted further the number of trees are 6 as per list enclosed at page No. 6. The total number of trees

including saplings should be included in the abstract of the trees enumeration list of saplings may also be placed in the proposal folders.

8. Against column No. I (i) Whether the Project or a part thereof is located in any Protected Area or their Eco sensitive zone, No has been mentioned. As per latest instructions received from received from Govt. of India, if the project is not located in the Protected Area, a certificate from the DFO concerned stating the distance of the project from Forest Area is required to be placed in the proposal folder.
9. Working plan prescription of the forest land proposed for diversion as given in column No.5 of Part-II is not correct. The working plan circle may be mentioned against this column in which the forest land proposed for diversion is falling.
10. Density of the land has not been mentioned in the NPV bill.
11. Digital map of the forest land proposed CA site is not placed in the proposal folder & digital map of the forest land proposed for CA and toposheet of CA site has not been found uploaded against column No. 13 (iii) & (iv) in online Part-II. Only digital map & toposheet of the forest land proposed for diversion has been uploaded against these columns.
12. Certificate from the DFO concerned that non-forest land selected for compensatory afforestation is in a compact block and contiguous to forest area or in close proximity of forest area and suitable from the management and protection point of view is not found attached with the proposal folders.
13. Suitability certificate from the Divisional Forest Officer that the land identified for compensatory afforestation is suitable for raising plantation is not found attached with the proposal folder.
14. Certificate from the Chief Secretary regarding non-availability of non-forest land in the state for raising compensatory afforestation, wherever applicable is not found attached in the proposal folder.
15. Before submitting proposal folders, it may be ensure that each and every document have been placed in the proposal folder as per checklist and pages number mentioned in the checklist. Many documents are not found placed in the proposal folder as has been mentioned in the check list.

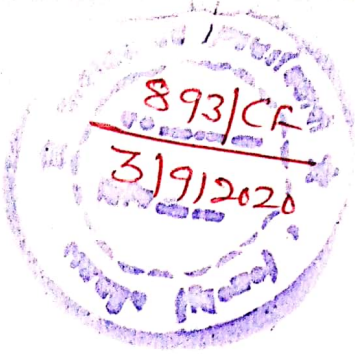
