Sir,

Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 12.052 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. The proposal was discussed for the fourth time in REC on 12.01.2022 and yet following information/clarification are still required to be submitted:


- (i) KML of the proposal is not uploaded correctly and lots of mistakes have been found during the DSS analysis. Muck dumping area, forest and non-forest patched in KML file are not clear. Proper KML with accurate area measurement to be submitted;
- (ii) The area statement of the proposed diversion should be well illustrated and self-speaking;
- (iii) DFO should verify the area statement through a dedicated site-inspection visit;
- (iv) Enumeration list of trees is erroneous. A fresh enumeration list to be submitted.

3. The compliance to the above may be submitted within 30 days from the date of issue of this letter failing which the proposal shall be liable to be rejected for want to information.
