7. In column 13 (i), NPV amount is inclusive in total CA outlay.
8. FRA uploaded under additional information of Part-II is without signature of District Collector.
9. KML file is not correct as unable to measure. Visually, the KML is of large area for plantation of 120 Plants, accordingly DGPS map also needs to be revised
