The Chief Conservator of Forests (T), Nashik vide letter dated 19/10/2023 has submitted Proposal for diversion of 6.3912 ha. forest land for Rehabilitation and Up-gradation of newly declared NH-752G section from Satana to Mandrul (From Km 64+000 to Km 101+140) to two lane with paved shoulders in the State of Maharashtra on Engineering procurement & Construction (EPC) mode. During scrutiny of proposal, following discrepancies has been observed in the said proposal:-

- As per Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and hence as per the provision of clause 16 Miscellaneous of Rule 8 of the Van (Sanrakshan Evam Samvardhan) Rules 2023 of sub rules (ii) Any provision of the extant rules will be applicable on the proposals which are yet to be granted 'In-principle approval under the Adhiniyam.
- In this proposal C.A is proposed on Degraded Forest land instead of non forest land of Compensatory Afforestation to be required in the project.
- However, the suitability certificate of non-forest land, C.A scheme, KML file and required Maps to be submitted.

You are therefore requested to submit above discrepancies at the earliest.
