**Diversion of 4.864 hectare of forest land in favour of M/s Bloot Fozal Hydro Pvt. Ltd., Apple Valley Resort, Mohal, Distt. Kullu, H.P. for the construction of Bloot Fozal Hydro Project (5.00 MW) within the jurisdiction of Kullu Forest Division, Distt. Kullu, Himachal Pradesh.**

The proposal received vide your above referred communication is found incomplete. The following shortcomings have been noticed in the proposal which is to be completed. Proposal folders received are returned herewith. All the requisite documents may please be placed in the proposal folder with proper numbering and index as per complete checklist.

1. The user agency has submitted Part-I of the proposal for diversion of 4.8640 hectare of forest land, whereas, the diversion has been sought for 4.8639 hectare in online Part-II and the proposal folder has also been submitted for diversion of 4.8639 hectare of forest land.
2. Working plan prescriptions has not been mentioned against column No. 5 in online Part-II.
3. Against column No. 7 ix of Part-II of the proposal folder, the approximate distance of the proposed site for diversion from boundary of forest has not been shown whereas in online Part-II against column No. 7, it has been mentioned as 0.
4. Progress of CA has been mentioned up to 31.03.2021. The progress of CA should be mentioned up to 31.12.2021 both in online Part-II as well as in hard copy of the Part-II of the proposal folder against District profile column.
5. Photocopy of FRA certificate has been found placed in the both of the proposal folder. Original copy/attested copy (from competent authority of Revenue Department) should be placed in the both of the proposal folder.
6. There is variation in the date of site inspection report as uploaded in Part-II against column No. 15 of online Part-II and placed in the proposal folder at Page No. 77.
7. CA is proposed to be raised over 9.72 hectare of degraded forest land as per CA scheme placed in the proposal folder at Page No. 81 whereas the area proposed for CA has been mentioned as 9.75 hectare in online Part-II against column No. 13 (i).
8. CA scheme as uploaded in online Part-II is not matching the CA scheme as placed in the proposal folder. It may be ensured that CA scheme has been prepared on current rate wage and has been uploaded against appropriate column in Part-II and placed in the proposal folder. Financial layout for CA may also be corrected accordingly in Part-II both in online as well as in hard copy of the proposal folder.
9. Bill of NPV is also required to be calculated in current revised rates and upload accordingly in online webportal and be placed in the proposal folder also.
