- 1. The project is involving submergence of part core zone and part buffer zone of Panna National Park besides Forest Area in Chhatarpur and Tikamgarh Forest Division and it appears to be in its pristine form.
- 2. Out of 6017.00 hectares forest area, photocopy of FRA Certificate is available only for 5258 Hectares, original documents are required to be submitted. For remaining area FRA Certificate has not been received.
- 3. Further to have correct assessment of various issues involved, a Committee consisting of Additional Director General of Forest (Forest Conservation), Dr. Deepak Apte, Dr. Sanjay V. Deshmukh, Shri Rajesh Kaushal, APCCF, Regional Office, Bhopal, IG (Forest Conservation), AIGF shall inspect the site, verify the relevant document/reports and furnish its report to MoEF&CC, which would be placed before FAC. Before the site visit Committee advised to provide all necessary documents to the committee members such as EIA report, NTCA site visit report etc. for further scrutiny
