The attention of the Principal Chief Conservator of Forests & Head of Forest Force, Andhra Pradesh, is invited to the reference 9<sup>th</sup> cited (copy enclosed), wherein the AIGF (Central), GoI, MoEF&CC, Sub-Office at Vijayawada of the Regional Office, Chennai, has informed that the authorization, as provided under Rule 15 of the Van (Sanrakshan Evam Samvardhan) Rules, 2023, for filing a complaint for the violation of the provisions of the Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980, against all the authorities/persons responsible for the said violation before the competent court, within a period of 45 days from the receipt of the letter. A periodic report on the progress of the matter may be provided from time to time.
