With reference to the above cited Proposal No. FP/OR/Others/46243/2020 on the subject, it is to inform that the forest diversion proposal for seeking prior approval of Gol, MoEF & CC under Forest Conservation Act,1980 for diversion of 65.4036 ha forest land for the construction of Jagdishpur-Haldia-Bokaro-Dhamra Pipeline (JHBDPL) Odisha Phase-2 project of GAIL, for non forest purpose (hard copy ) has been received in this office on 25.1.2021. On scrutiny of the above Diversion Proposal, the following deficiencies are noticed.

- 1. As per Prescribed proper Check list under Forest Conservation Act,1980 Guideline duly filled in mentioning the page number and all necessary undertakings required as per check list with signature of the Authorized Signatory has not furnished with the Diversion Proposal.
- 2. As per item No. 2 of Check list authorization of the project authority. Position of the authorized person in the company with the signature attested has not furnished.
- 3. Certificate from concerned Tahasildars regarding status of total land involved in the project (both forest & non forest ) as per Govt. record as in 25.10.1980 has not furnished.
- As per item No 5 of Check list Topo map ,DGPS map has not authenticated by concerned Forest Guard, Forester & Range Officer Angul/Chhendipad Range.
- 5. As per item No 6 of check list Layout plan of the project site /( liner projectdiagrammatic map of the project site has not furnished with Proposal.
- As per item No 7 of Check list, Statement showing the details of Revenue forest area involved proposed for diversion has not duly signed by concerned Tahasildars and Reserve forest involved including Survey No.

/Coup No. Compartment No. etc signed by Forest Guard, Forester and Range officer has not furnished.

- 7. Abstract of Forest area and non-forest area to be diverted authenticated by concerned Tahasildar has not furnished with diversion proposal.
- As per Item No. 13 Compensatory Afforestation land has not identified in the proposal.
- The village sheet of the revenue forest land to be diverted has not signed by concerned Tahasildar, Banarpal
- 10. As per item No.8 statement giving the details of non-forest areas involved in the proposal, The land schedule and the map attested by revenue authority has not furnished.
- The DLC forest within the applied area should be shown in green colour in all Maps.
- 12. The area applied for diversion in Angul forest Division should be delineated in distinct ink in the Map showing the alignment of the project which has not furnished.
- 13. The proposal should be serially page numbered with Annexure numbering.
- 14. As per item No. 19 of check list species-wise and girth class wise enumeration list and abstract of trees of Non-Forest Land has not furnished.

15. .Undertaking as per check item No. 13 &m 16 is wanting.
