Please refer to the State Government letter F. No. FRS.254/2018/80 dated 20.12.2018 on the subject cited above, seeking prior approval of the Central Government in accordance with Section 2 of the FCA, 1980. I am directed to inform that the proposal referred above has been examined in this office in the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The following additional information/documents are found lacking:-

- 1) The aerial distance of the proposed area from the nearest Protected Area/Wildlife Sanctuary/National Parks.
- 2) The undertaking for compensatory afforestation from the user agency.
- 3) The original copy of the C.A. scheme technically approved and duly signed by the competent authority.
- 4) The NPV calculation of the proposed area.

- 5) To submit the complete information on the Sl.No. 10 of the forwarding letter of State Govt letter mentioned under reference above as the same has not been filled up.
- 6) To clarify on the requirement of forest land for the approach road to the proposed area.
- 7) The status of Environment clearance.


