

**Sub: Proposal for diversion of 23.80 ha of forest land (as per sabik records as on 25.10.1980) including 2.240 ha of forest land in safety zone area of Chromite ore mining of Kalarangiatta Chromite Mine of M/s Ferro Alloys Corporation Ltd. (FACOR Ltd.) in Cuttack Forest Division coming under jurisdiction Sukinda Tehsil of Jajpur district, Odisha (Proposal No.FP/OR/MIN/16453/2015)**


In inviting a reference to F&E Department letter No.10F (Cons) 228/2016-583/F&E dated 08.01.2019 of Special Secretary to Government addressed to this office and a copy thereof endorsed to you vide next memo of even date on the above mentioned subject, you are requested to furnish the revised CA scheme raised over 14 ha of open forest category of forest in non-forest land identified / allotted for the purpose of CA land the Kerajodi village of Kankadahada Tahasil of Dhenkanal district pertaining to the above project through your RCCF at latest wage rate i.e. Rs.280/- per manday with cost of maintenance of 10 years alongwith all requisite such as authenticated map of CA land, Shape file of CA area, DGPS readings, land suitability certificate by you indicating specifically with regard to the extent of land accommodating the number of required plants as per Govt. of India guidelines dated 08.11.2017 on CA, non-encroachment / non-encumbrance certificate of the concerned Tahasildar etc to this office for onward transmission Govt. in F&E Department at an early date.


