the light of Forest (Conservation) Act, 1980, and rules/guidelines framed thereunder. The following

- 1) To submit the complete information on the Sl.No. 10 of the forwarding letter of State Govt
letter mentioned under reference above as the same has not been filled up.
- 2) To clarify on the requirement of forest land for the approach road to the proposed area.
- 3) As per the submitted Mining Plan of this proposal at Sl. No. 9, the proposed area is to be
allotted to Shri Fatik Das. State Govt is to clarify the user agency of this proposal whether Shri
Fatik Das or DFO, North Kamrup District.
- 4) To comment on the background history of the proposed site, as it is observed to be already
mined in the past as per the Google Satellite images.
