**विषय:** Diversion of 0.6995 ha. of forest land in favour of M/s Dani Maha Mai Hydro Project for the construction of 1.0 MW Barod SHEP within the Kullu jurisdiction of Forest Division, Distt. Kullu H.P.

**सन्दर्भ:** Online proposal no FP/HP/HYD/21645/2016 reply received on 20.11.2024.

महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भांकित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.6995 हेक्टेयर वन भूमि की मांग की गई है।

2. राज्य सरकार द्वारा इस कार्यालय के समसंख्यक पत्र दिनांक 09.04.2024 के अनुपालन में भेजा गया स्पष्टिकरण पूरी तरह से स्पष्ट नहीं है, अतः प्रस्ताव से सम्बंधित जानकारी भेजने का कष्ट करें:-

1. As per the DSS, KML file Area evaluated for the proposed forest land is approx. 0.24 (ha.) instead of 0.6995 (ha.). State Govt shall upload the revised KML in polygon form for all the desired documents as mentioned in the component wise breakup Column-B 2.4, Part-I of PARIVESH portal
2. State Govt shall submit the project specific justification for locating the project in Forest area in S.No-D (i), Part-I.
3. It seems from the KML file, diversion area is on slightly steep and vulnerable to erosion.. Therefore, the State Government may provide details of mitigation measures to be adopted to prevent soil erosion/landslide during/after execution of the project. In addition, the State Government may submit soil and moisture conservation plan as per Para-1.22 (ii) of the V(SS)A, 1980.
4. It has been observed from KML file that Transmission Line is proposed in extant project, however it is not connected with any sub-station. Therefore, sub-station in KML/Layout Plan in which the transmission line is proposed to be connected may be marked with NoC from HPSEB/HPTCL or any Govt agency as the case may be.
5. State Govt. may provide the details regarding the power Evacuation Plan mentioning capacity of transmission line as well as proposed road (length and width) and mode of transmission. Also, State Govt. may clarify whether transmission line is underground or above ground
6. Legible copy of Layout Plan be uploaded on the PARIVESH portal as well.
7. State Govt shall upload the detailed Muck Management plan, details of muck generated, disposal of muck with proper action plan. Also, State Govt. shall upload the reclamation Pan for reclamation of dumping site with

- details of protection measures/ final outlay duly authenticated by concerned DFO may be provided
8. State Govt shall provide the exact aerial distance certificate from the nearest WLS/PAs and form its notified or proposed ESZ to the proposed project.
  9. State Govt shall submit the revised Joint Site inspection Report with factual details of the proposal alternate examined, No of trees etc, duly authenticated by members present during the meeting.
  10. State Govt may provide/upload the Abstract of trees with detail of Khasra no, duly authenticated by DFO concerned.
  11. As per the DSS analysis, the proposed CA area is crossing the existing road. Also, on corner of the polygon is already landslide prone zone. State Govt shall review and change the proposed CA area with CA site having canopy density less than 40%. Part-II, column-14, geographical area of district may be reviewed and rectified.
  12. State Govt. shall strictly ensure to upload the individual documents by name in the respective S.No of Part-I instead of uploading the complete folder of the proposal.
  13. 22 numbers of important trees are proposed for felling. Therefore, possibility of reducing the numbers of trees to be affected may be explored or rationalisation to be done in the layout of the proposal to reduce green felling. Further, a list of trees which are required to be felled and retained (Not to be felled) may be provided.
  14. State Govt. Shall provide the certificate of non-availability of NFL from Chief Secretary for proposing DFL under special provision Para 2.2 (iv) of Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023, MoEF&CC.
