विषयः. जनपद-उत्तरकाशी में नेहरू पर्वतारोहण-संस्थान, उत्तरकाशी के प्रशिक्षणार्थियों के प्रशिक्षण हेतु हुर्री में 0.92 है0 वन भूमि के हस्तान्तरण के सम्बन्ध में। (Online Proposal No. FP/UK/OTHERS/43291/2019).

महोदय

उपर्युक्त प्रस्ताव पर ध्यानपूर्वक विचार करने के उपरान्त मुझे आपको यह सूचित करने का निर्देश हुआ है कि विषयांकित प्रस्ताव में निम्नलिखित त्रुटियाँ पाई गयी है। राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनायें प्रेषित करने का कष्ट करें ताकि प्रस्ताव में अग्रिम कार्यवाही सुनिश्वित की जा सकेः

- 1. From the proposal, the nature of the work to be carried out is not clear. State Govt. is requested to provide information/documents/ clarification/ justification on the following:
 - i. The nature of the proposal along with the detailed layout plan of the activity and the component wise breakup.
 - ii. Training for whom, defense forces or private tourists is to be carried out?
 - iii. Why we need such training camps in such pristine and undisturbed areas which is the important habitat of mountain wildlife?
 - iv. How State Govt. is viewing this as public utility project?
- 2. Although this proposal is not leading to tree felling, but this will surely affect the alpine meadows of the fragile ecosystem. The State Govt. is requested to submit clarification in this regard.
- 3. State Government is requested to clarify as to how proper sewer mechanism without discharging human excreta adjoining the Himalayan streams will be ensured when trainee's camp is there.
- 4. It is requested from the institute to submit the information regarding:
 - i. Where and how the institute been doing the above activities, so far?
 - ii. If till now this work has been done elsewhere, what is the need for diversion of new forest land for this now?

- 5. Since, there is no felling involved in this proposal but 80 trees are reported to the site which are to be retained, therefore plantation scheme of 800 trees by way of CA is required to be submitted from the State Govt. along with the details of degraded forest area (KML, Map etc) that would be used for planting 800 trees as per the working plan prescription is also required to be furnished.
- 6. The proposed area is probably a part of Bhagirathi Eco-sensitive Zone, therefore recommendation of the concerned committee is required to be furnished to this office.
- 7. Site Inspection Report of DFO shall be submitted in enclosed format.
- 8. A detailed Layout plan showing the permanent and temporary structures (along with KML file) duly authenticated by the competent authority with consent of DFO is required shall be submitted.
- 9. As the proposal is non site specific in nature, specific comments from the State Government is require to be submitted.
- 10. The User Agency shall submit a certificate from concerned District Collector that no such revenue land is available for this project.
- 11. The details of approach road with specific comments of concerned DFO is required to be submitted so that the connectivity issue may be explored.
- 12. Revised NPV calculation sheet as per the revised rates shall be submitted.
- 13. Administrative approval/ financial sanction of the proposal duly approved by the competent authority is required to be furnished.
- 14. There are two proposals (0.98 ha- FP/UK/Others/43304/2019 and 0.92 ha-FP/UK/Others/43291/2019) for the same purpose of the same UA in Uttarkashi Forest Division. The User Agency and DFO shall submit the reasons for non-submission of consolidated proposal.
- 15. The details of CA over non-forest land is required to be submitted from the State Govt. along with the details of CA scheme, area suitability certificate, KML file and Maps.
