

Ref: EDS replied by your office to the latest EDS query raised by Gol.

With reference to the above proposal, the Government of India vide Ref (3) has raised an EDS Query seeking the details of compliance report for the conditions stipulated by ministry vide letter dated 14-12-2004 for diversion of 449.55 Ha of forest land to Upper Tunga Project. But as per the condition No. 11 "Reservoir so created shall be declared as Reserved Forest under Indian Forest Act, 1927 and regulated fishing rights shall be allowed", you have replied that necessary steps will be taken to notify the reservoir created in the above divisions as Reserve Forest. It's been very long pending to process this matter.

You are directed to take necessary steps to notify the reservoir created in your divisions as Reserve Forest.


