Sir,

On the subject cited above, the undersigned wants to draw to your kind attention to the fact that certain deficiencies have been noticed in respect of the Essential Documents submitted by you for the forest clearance of PMGSY road **Riar to Baggan**. Therefore, you are requested to provide the following Essential Documents to this office enabling the undersigned to proceed further in the matter:

- 1. Coloured Survey of India Toposheet Map of the project site as prescribed under the Forest (Conservation) Rules, 2003 has been uploaded but without Legend. Kindly take corrective action and furnish hard copies.
- 2. Detailed Muck Disposal Plan may kindly be provided alongwith the corresponding dumping sites clearly mentioning the quantity of muck likely to be generated and its eventual dumping site-wise disposal in quantitative terms along with the detail of muck retention structures like retaining wall to be constructed for the purpose as the terrain bears moderate to steep slopes. The muck dumping sites and existing road must also be depicted on KML file uploaded on PARIVESH and furnish the corrected hard copies of GPS map with suitable Legend.
- 3. Furnish revised hard copies of the project as per Form-A (Part-1).
- 4. Furnish the duly signed checklist of all the mandatory documents enclosed in the Form-A (Checklist has already been circulated. However, a copy is enclosed again)
