महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से सम्बन्धित संदर्भांकित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 0.0103 हेक्टेयर वन भूमि की मांग की गई है।

2. अतः प्रस्ताव से सम्बन्धित निम्नलिखित जानकारी भेजने का कष्ट करे:-

- (i) The justification submitted by the User agency is not satisfactory. It should have been the total period for which the forest land is proposed to be diverted.
- (ii) NOC from PWD department and CLU certificate has been submitted. However, the document submitted from PWD and CLU are addressed to M/s Dineshchandra R. Agrawal Infracon Pvt Ltd, but the latest communications between DFO and UA are as M/s Dineshchandra Giriraj Infra Pvt Ltd. We need clarifications for this inconsistency as well.
- (iii) The LOI submitted is in the name of M/s Dineshchandra R. Agrawal Infracon Pvt Ltd., and for supply of HSD only, whereas the proposal submitted for approval is Establishment of Hot mix plant, Wet mix plant, RMC Plant and HSD Pump. Perhaps, the proposal for diversion and the LOI should be in same name and indicating same activity. Here, additional activities such as Hot mix plan, wet mix plant, RMC Plant etc have been included in the online proposal and matching documents for them are not provided.
- (iv) There is mismatch between as submitted online and clarification provided. As per Part I of proposal on PARIVESH, the project falls in the MEWAT district, whereas as per clarification and drawing submitted, the project area falls in Nuh Revenue district. Please Clarify.
