- 15) The APCCF(LM), Govt. of MP reported that the non-forest land for CA is 28.77 ha which is having the CD 0.7. However, the remaining saplings shall be planted at 20.00 ha degraded forest land at Survey no 574, Rahti Range, Sehore Forest Division and CA scheme for 10 years is submitted.
- 16) CCF (T), Nodal Officer and State Government have recommended the proposal for approval.
- 17) The Regional Office had sought information from State Govt. of Madhya Pradesh vide letter dated 28/12/2018 on following points:
 - a. The KML file and maps submitted with regard to proposed diversion does not show Spill way. Hence same shall be submitted.
 - b. The SIR of DFO, Sehore mentioned that proposed area is outside 10 Km of boundaries of nearest Protected Area. However DSS analysis shows that the proposed area is 5.61 Km away from Ratapani Wildlife Sanctuary. Hence this may be clarified and CWLW comments accordingly shall be submitted.
 - c. The DSS analysis shows that the KML file of proposed area is 1.5 ha excess against proposed 28.77 ha. This may be relooked and correct KML file in accordance to proposed diversion shall be submitted.
 - d. The KML file, Soiltoposheet map and geo-referenced map of 20 ha degraded forest area (survey no. 574) shall be submitted.
- 18) The State Govt. had submitted its reply vide letter dated 31/12/2018.

Recommendations of REC:

The REC examined the proposal for diversion of forest land under the Forest (Conservation) Act, 1980 and considered the reply submitted by the State Govt. of Madhya Pradesh vide letter dated 31/12/2018. The REC also saw the proposal on the Decision Support System (DSS) of FSI.

The REC ~~defers~~ the proposal for diversion of 28.77 ha Protected forest land for construction of Amirganj Tank Project in Village- Amirganj in favour of Executive Engineer, Water Resources Division in Sehore District in Madhya Pradesh on want of following information:

1. There are two (2) KML files for the dam and submergence area submitted. It is not clear as to which KML file for dam and submergence has been approved by the State Govt.
2. The State Govt. shall submit the revised KML file of proposed area and height of the dam with the approval of Competent Authority in the State Govt.

- 4) In addition to the above forest land, 1.639 ha non-forest land is also required.
- 5) The estimated cost of the project is Rs. 672.06 Lakh and manpower to be generated, Permanent- 05 & Temporary- 10 person.
- 6) Cost-benefit analysis is submitted. The proposed irrigated area is 226 ha.
- 7) Density of vegetation is 0.3 and 203 trees are marked for felling on the proposed forest land 161 number of trees upto 60 cm. Species-wise & girth-wise details have been made available
 - a) No. of trees at FRL Level - 203 trees.
 - b) No. of trees at FRL -2M - Nil.
 - c) No. of trees at FRL -4M - 72 trees.
- 8) It has been certified that the requirement of proposed forest land is unavoidable & barest minimum.
- 9) The Certificate of Collector under FRA, 2006 is submitted.
- 10) The Site Inspection report in prescribed format of the concerned territorial DCF is submitted. There is no violation of Forest (Conservation) Act., 1980.
- 11) The proposed forest land does not form any part of National Park/Wildlife Sanctuary/Biosphere Reserve/Tiger Reserve/Elephant Corridor etc. and the proposed project is outside 10 km of the boundaries of the nearest protected area
- 12) There is no protected archaeological/heritage site/defence establishment or any other important monument located in the proposed area
- 13) Displacement of people and rehabilitation plan is not involved in the project.
- 14) CA is proposed over 17.178 ha (out of 79.279 ha) non-forest land (Khasra No. 261/2, Village- Naharpura, Tehsil- Sardarpur, District-Dhar. The land is found suitable for raising plantation. Map of CA and CA scheme for 10 years is submitted.
- 15) CCF (T), Nodal Officer and State Government have recommended the proposal for approval.
- 16) The Regional Office had sought information from State Govt. of Madhya Pradesh vide letter dated 28/12/2018 on following points:
 - a. The KML file of 1.639 ha non-forest land involved in the project shall also be submitted.
 - b. The proposed CA appears to be rocky as found in google/ satellite imagery and also no plant impression is noticed over the past 10 years over proposed CA area. Hence revised CA land with good soil depth shall be submitted.
 - c. NOC of Gram Panchayat & proceedings of Gram Sabha shall be submitted.
 - d. Alternative statement as submitted is not on par with that uploaded on webportal. This may be relooked.
- 17) The State Govt. had submitted its reply vide letter dated 31/12/2018.

Recommendations of REC:

The REC examined the proposal for diversion of forest land under the Forest (Conservation) Act, 1980 and considered the reply submitted by the State Govt. vide letter dated 31/12/2018. The REC also saw the proposal on the Decision Support System (DSS) of FSI and following observations are noted:

1. As per DSS analysis on CA land, the proposed CA land falls in rocky and barren area.
2. As per DSS analysis of proposed diversion, area shows that the entire area is in compartment no. 390, Sardarpur range, Dhar which is contrary to the information submitted by the State Govt.

Accordingly, the REC ~~defers~~ the proposal for diversion of 17.178 ha Protected forest land for construction of Kundiyanalla Minor Tank Project in favour of Executive Engineer, Water Resources Division in Dhar District, Madhya Pradesh on want of following information:
