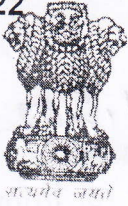

महोदय,

उपरोक्त विषय पर संदर्भित पत्र का आशय ग्रहण करने हुए सूचित करना है कि प्रस्ताव में निम्नलिखित कमियां पाई गयी हैं। अतः राज्य सरकार निम्नलिखित बिन्दुओं पर आवश्यक सूचनाएं प्रेषित करने का कष्ट करें, ताकि प्रस्ताव पर आगामी कार्यवाही सुनिश्चित की जा सके:-

1. The annexures enclosed with FRA certificate are neither issued by FRC of concerned village nor all records of consultations and meetings Gram Sabha(s) and FRC(s) are found enclosed. Therefore, all prescribed annexures along with consultations and meetings of Gram Sabha(s) and FRC(s) of concerned villages be provided to this office.
2. The revised NPV and Penal NPV calculation sheets as per MoEF&CC order dated 06.01.2022 be provided to this office.
3. As per proposal, dumping site is proposed in private land. This needs to be updated in Part-I, Para-B.2.4 in component wise break up.
4. Most of the documents provided with the proposal are not authenticated by DFO concerned. Therefore, all the documents of the proposal (including no muck dumping certificate) may be authenticated by the DFO concerned.
5. In CA Scheme, name of forest block is mentioned as DPF Sadiar, however it is mentioned as UPF Sadiar in land suitability certificate. Therefore, State Government may review the same and correct it accordingly.
