Kindly refer to the online proposal of Government of Jammu & Kashmir on the above-mentioned subject seeking prior approval of the Central Government for diversion of 3.0375 ha of forest land for non-forestry purpose in accordance with section-2 of the Forest (Conservation) Act, 1980.

2. After careful examination of the aforesaid proposal following information/clarification are still required to be submitted:

(i) Alternate route of the proposal is not yet provided by the user agency; as this proposal is for construction of new road, so alternate route explanation to explore the possibility of avoiding the forest area or further reducing the forest area involved is required.
