The attention of the Principal Chief Conservator of Forests & Head of Forest Force is invited to the reference cited wherein it has been informed that the User Agency has submitted No object certificate from Sree Balaji mineral for utilizing a part of the approach road proposed by Sree Balaji minerals from the proposed mining area to outside forest area for transportation of mineral. In this regard, he is informed that the said diversion proposal is not even got Stage-I status and proposing to use this road in the present proposal needs to be justified.

2. Further, as seem from the DGPS map the width of the safety zone is varying and it has to be examined as per the guidelines.

3. Hence, he is requested to furnish length and width of the safety zone details along with justification as per GoI guidelines to take further action.
