It is to inform that in reference 1<sup>st</sup> cited, the Prl.Chief Conservator of Forests, Andhra Pradesh, Guntur has addressed a letter to the Director of Mines & Geology, Ibrahimpatnam, Krishna District to furnish the Approved Mining Plan by getting the Draft Mining Plan from the user agency for the precise forest area and also submit the information regarding the mineral with their capacity and average annual production and projected future requirements in the State of Andhra Pradesh. Accordingly, the District Forest Officer was instructed to obtain the same and resubmit the proposals in Conservator of Forests, Kurnool Rc.No616/2019-TO, Dt.26.11.2021.

*is only uploaded in web portal.*



Therefore the District Forest Officer is requested to upload the Approved Mining Plan into web portal and also obtained the information regarding other mining leases for a particular minerals with their capacity and average annual production and projected future requirements etc. from the Director of Mines & Geology, Ibrahimpatnam and upload into the web portal and resubmit the proposals with hard copies in (4) sets to take further action in processing the proposals at an early date.
