Sub: Proposal for seeking prior approval of the Central Government under Forest (Conservation) Act, 1980 in favour of Uttarakhand Forest Development Corporation, Mining Division Ramnagar for renewal of Collection of Minor Minerals from 112.0 ha (Originally approved area is 223.0 ha) of forest land of Dabka river under Forest Division Ramnagar and District Nainital, Uttarakhand (Online proposal no. FP/UK/MIN/147953/2021).

Madam/Sir,

I am directed to refer to your online proposal No. 1260/FP/UK/MIN/147953/2021 16.11.2022 submitted the additional information on the above mentioned subject for seeking prior approval of the Central Government under Section 2 (ii) of Forest (Conservation) Act, 1980 and to inform that after examination of the additional information in the Ministry revealed the following shortcomings:

1. The State/UA has applied for the renewal of diversion of forest land for next 10 years, however, the mining plan has been approved upto February 2023 only. Further, the State has informed that the mining plan is under process for approval for the next five years whereas the renewal is being sought for 10 years. In this regard, the approved mining plan for commensurate time period is required to be provided.
2. Cost Benefit Analysis has not been submitted as per the format prescribed in the FCA, Handbook of guidelines dated 28.03.2019.
3. The State has informed that the DSR report has been prepared only up to 2018. Fresh DSR for the proposed area is required to be submitted as per the Enforcement & Monitoring Guidelines for Sand Mining Guidelines- January 2020.
4. The supportive documents in the compliance of the conditions no. (v) of the Stage-II approval dated 15.02.2013 wherein it has been mentioned that "the collection of minor minerals after 31st day of January in a year shall be allowed only after receipt of certificate from the Monitoring Committee under the Chairmanship of the Principal Chief Conservator of Forests, Uttarakhand constituted vide Government of Uttarakhand's letter No. 14-1/X-3-13-08(14)/2008-T.C. dated 29.01.2013 to the effect that the conditions stipulated in the approval accorded under the Forest (Conservation) Act, 1980 and the instructions issued by the Monitoring Committee have satisfactorily been complied in collection of the minor minerals during the previous calendar year may be provided.
