Subject: Diversion of 2.1 ha. of forest land in favour of Executive Engineer, Rajasthan Agricultural Marketing Board, Division-Tonk for construction of *Missing Link Road* (Dooni Anwa Road to Chandli Maata ji Temple) under Forest Division Tonk, District Tonk, State Rajasthan.

Dear Sir,

On the above mentioned subject this office has received an online proposal for clearance under Forest (Conservation) Act-1980. The hard copy of the proposal has not been received in this office till now. The details of the proposal are as given below-

In the proposal it has been observed that-

- The FRA certificate has been submitted for the land proposed for CA instead of the land proposed for diversion. The FRA certificate for the land proposed for diversion should be submitted.
- The user agency has done construction work in violation of FCA 1980. The territorial DCF has lodged an FIR but the present status of FIR has not been informed.
- The DCF has done site inspection on 23<sup>rd</sup> Sept 2015. The detailed report on FCA Violation has been neither submitted in the Hard Copy nor uploaded on the FCA Portal.
- In the geo-referenced map of the proposed road, at one end of proposed road (near Latitude 25°47'37" Longitude 75°33'55") an existing road has been shown in the forest area. Details of FCA approval for this part of (existing) road in forest area should also be submitted.

- e) The site inspection was done by the concerned territorial CCF on 17<sup>th</sup> Sept 2015. As per the site inspection report of CCF, vide letter no 6157-61 of his office, Conservator of Forests Ajmer was asked to enquire into the issue and submit detailed report. Latest status may be submitted
- f) The details of CA, estimates, site suitability certificate and KML file have not been provided.
- g) The detail of afforestation site and estimates for TEN times of area violated as penal CA should also be submitted.

I have been directed to inform you to provide the above mentioned information along with the hard copy of the proposal. On receipt of hard copy, if any further information is required it will be informed in the due course of time.
