
2. The following shortcomings are still noticed which may be attended in all respect:-
 1. In reply to point No. 2 (i) complete legible list of 2183 has still not been found uploaded instead of this, blur extracted copy of list has been uploaded which does not serve the purpose. Further, in reply of point No. 2 (ii) the copies of order of Hon'ble High Court has also not been found uploaded. The complete legible copies of order stating the No. & titled of column be uploaded online portal.
 2. In reply to point No. 4, administrative approval still not been found uploaded, same may be uploaded stating the number & titled of column against which it is uploaded.
 3. In reply to point No. 6, segment-I of KML file still seems deviated from existing parth/ road.
 4. In reply to point No. 7, the soil and moidsture conservation plan alongwith detailed cost of its implementation is not found uploaded in online portal.
 5. In reply to point No. 8, distinct colours of forest / non forest/ violated part is still not be mentioned.
 6. The certificate of minimum use of forest land as asked at point No. 10 has not been found uploaded in online portal.
 7. The reclamation plan of dumping sites have not been uploaded in portal.
 8. In reply to point No. 17, user agency stated to have been replied, instead of this comments of DFO/ CCF is required in this regard. Further, list of trees required to be felled and retained also be provided.


