With reference to the above mentioned subject and letter under reference, I am directed to request you to submit/upload the following information/documents:

- 1. As per DSS analysis, proposed diversion KML is coming to 6.29 ha in place of 3.4134 ha. Thus, the correct KML file of proposed diversion of 3.4134 ha shall be submitted and uploaded on e.portal.
- 2. The CA scheme of 3.4134 ha shows the preparation of Model-3 type plantation on the selected non forest land for 10 year is submitted, which attracts Para 2.8(iii) of F(C) Act, 1980 Handbook 2019. Thus revised site specific CA scheme of 10 years maintemance shall be submitted as per the Para 2.8 (iii) of FCA Handbook 2019 and shall include the following points also:
 - a) Saplings to be planted (Minimum standard height and collar girth species wise).
 - b) Soil & Moisture conservation works.
 - c) Regeneration cleaning.
 - d) Silvicultural and other activities as prescribed in the working plan.
 - e) Species to be planted (species wise number of plants).
 - f) Details of proposed monitoring mechanism/outcome parameters.
 - g) Technical and administrative approvals from the competent authority.
 - h) The revised CA scheme shall be uploaded on e.portal.

Further, necessary action will be carried out after receipt of above information.
