Kindly refer to your office letter No.PW/GHD/CB/WA/Forest case/2021/5499-5500 Dated 03.09.2021. on this subject cited above.

2. Form the perusal of proposal folders received vide your office letter under reference, the following shortcomings have been noticed:
 1. In the check list of the proposal folders, the page Nos have been marked with erasable pencil.
 2. In duplicate folder photocopies of maximum documents have been placed. All the photocopies duly attested are required to be placed in the proposal folder.
 3. Layout-plan of project site is not attached.
 4. In the digital map of the forest land proposed for diversion, the detail of dumping site have been marked by the ball pen with black ink which is not acceptable. The digital map may be revised and prepared a fresh showing index of dumping site also.
 5. Digital map and KML file is differ.
 6. The road has been constructed in violation of FCA 1980 as such Extent of violation and name of authority which is responsible for violation may also be intimated. A note on violation is required to be placed in proposal folder.
 7. It may also be intimated as to whether this road is included in the list of 2183 case or otherwise.
 8. The enumeration list/abstract of trees proposed to be felled is required to be submitted in species- wise with local/scientific names in dia-class in the following format:-
