महोदय,

मुझे आपका ध्यान उपर्युक्त विषय से संदर्भित पत्र की ओर दिलाने का निर्देश हुआ है, जिसमें वन (संरक्षण एवं संवर्धन) अधिनियम, 1980 की धारा- 2 के अनुसार गैर वानिकी उद्देश्य के लिए 3.9654 हेक्टेयर वन भूमि की मांग की गई है।

2. राज्य सरकार द्वारा इस कार्यालय के समसंख्यक पत्र दिनांक 19.11.2024 के अनुपालन में भेजा गया स्पष्टिकरण पूरी तरह से स्पष्ट नहीं है, अतः प्रस्ताव से सम्बंधित जानकारी भेजने का कष्ट करे:-

1. **In reference of the observation No. 2, REPLY IS NOT ACCEPTED**, details regarding the action taken against the violation as per provisions mentioned in consolidated guidelines and clarifications issued under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and Van (Sanrakshan Evam Samvardhan) Rules, 2023 was sought. In reference to this State Govt has not submitted any action taken reports. Therefore, State Govt shall submit the detailed and fact full report with supporting documents, duly authenticated by DFO concerned.
2. **In reference of the observation No. 3, REPLY IS NOT ACCEPTED**, detailed status report to the Regional Office in case of 2183 road projects for which directions have been passed by Hon'ble High Court of Himachal Pradesh including the detail of proposals already approved under Van (Sanrakshan Evam Samvardhan) Adhiniyam, 1980 and the balance cases that are yet to be processed was sought from the State Govt. The decision in such type of cases shall be taken holistically by Regional Office and forward the same to the Ministry along with its comments/recommendations. **In reference to this, State Govt. has not submitted the relevant and fact full reply. Therefore, State Govt. shall submit the detailed Status reports of the 2183 road projects for which directions have been passed by Hon'ble High Court of Himachal Pradesh.**

Also, it is pertinent to mention here that, the State Government/Nodal Office shall ensure completeness/proper justification/relevant documents and their

comments before forwarding the proposal to the Regional Office. This process not only ensures speedy disposal of the proposal but also saves valuable time of both the offices.
