Sub: Proposal for diversion of 0.890 ha (map area 0.894 ha) of Revenue Forest Land for establishment of Mayurbhanj College of Accountancy and Management at Maharajpur, PO-Takatpur in the District of Mayurbhanj under the jurisdiction of Baripada Forest Division.(Proposal No.FP/OR/SCH/124019/2021)

Sir,

I am directed to invite a reference to your office Letter No.25250, dt.27.12.2023 on the captioned subject and inform that, on scrutiny of the above Forest Diversion Proposal it is noticed that the DFO, Baripada Forest Division in his Site Inspection Report (**Page No.36-37/DP**) has reported that 0.890 ha revenue forest land proposed for diversion is already in use **since 24.06.2007**. But the PCCF (FD&NO, FC Act) in the letter referred under in Point No.13 has reported that, the forest land proposed for diversion is in use **since 19.11.2003**.

Further, on the matter of imposition of penalty for violation the stand taken by DFO and PCCF (FD&NO, FC Act) are different.

In this regard, you are requested to kindly furnish the necessary clarification to this Department for further action at this end.
