विषय:- Diversion of 4.584 ha. of forest land in favour of Upgradation of Road from Bhanpura Kalan to Gol Via Nagal Tulsidas, Toda Meena, Tala, Jaichandpura, Gathwari, Bobari, Under PMGSY-III, District -Jaipur (Rajasthan) (Proposal no. FP/RJ/ROAD/149378/2021)

महोदय,

उपर्युक्त विषयान्तर्गत संदर्भित पत्र के क्रम में प्राप्त प्रस्ताव का परीक्षण करने पर निम्नांकित सूचनाएँ दिया जाना आवश्यक है:-

1. There is a difference between Google map and DGPS map especially in non forest land in Jamwa Ramgarh Sanctuary.
2. The proposed alignment is shifted from original alignment.
3. The proposed area falls inside Jamwa Ramgarh Sanctuary but proposal for wildlife clearance has not been submitted.
4. Order for District Collector for providing compensatory afforestation (NFL) has not been kept reserved.
5. Some encroachment is visible inside the corner of NFL.
6. Area calculation sheet for sanctuarywise (Forest and non forest land) has not been provided.
7. Document for the existing road was constructed before 1980.
8. DCF north and DCF WL jaipur mention that no trees falling inside the proposed forest area but some vegetation are visible inside the proposed forest area.
9. There should be 4854 plants (1000 plants per ha.) to be planted but CA scheme is provided for only 2300 plants.
10. One another CA scheme for 5.19 ha also uploaded which have to be removed.
11. Management plan prescription of the proposed forest area has not been uploaded.
12. NPV details has not been submitted by DCF WL Jaipur
13. Copy of notification of forest land/sanctuary has not been provided.
14. Proposed forest land has not been marked in revenue maps.
