Attention of the Divisional Forest Officer, Wildlife Management Division,
Markapur is invited to the reference 4th cited, wherein he has reported that the
proposals in Part-II Form A of "Laying of Optical Fiber Cable along the road within
in the right of way (RoW) passing through forest under WL Markapur Division over
an extent of 0.15 Ha. for providing 4G Communications in the State of Andhra
Pradesh in favour of M/s Reliance Jio Infocomm Ltd., Visakapatnam are uploaded
through online in the Ministry's web site on 06.12.2019 and submitted the
proposals in (6) sets to this office. But on verification, the proposals are not in full
shape and the Part-II information is also not submitted. Hence the proposals are
returned herewith.

Further the Divisional Forest Officer is requested to submit a/certificate in the
prescribed format Annexure -I (Form-I) for linear projects duly certified by the
District Collector for evidences for having initiated and completed the process of
settlement of rights under the Scheduled Tribes and other Traditional Forest
Dwellers (RoFR) Act, 2006 duly annexed to each set of the proposal. He is also
requested to critically examine the requirement of forest land for the above project
and satisfy himself that the requirement of land for the project is unavoidable. He
is also requested to carry out the site inspection and enclose the field inspection

report with the photographs of spots visited and the same included in the Field Inspection Notes; take up enumeration of trees to be felled if any, in the proposed areas for diversion and submit Abstract of enumeration, species and girth class-wise in the prescribed proforma. He is requested to specifically mention about the source and / or method for indicating the density of vegetation vulnerability to soil erosion, the impact of the projects on the adjoining flora and fauna and also suggest mitigative measures for the protection of flora and fauna and record specific recommendation or otherwise for the projects and submit the same to this office.

The Divisional Forest Officer, Wildlife Management Division, Markapur is further requested to specifically mention the proposed area is falling in National Park/ Wildlife Sanctuary, or within the Eco-sensitive zone and also mention the exact distance from the nearest WLS / NP duly enclosing the location map. He is also requested to verify with reference to any pending claims on the said forest land, encroachments, if any, court cases pending if any and leases to APFDC Ltd., etc.,

Therefore, the Divisional Forest Officer, Wildlife Management Division, Markapur is once again requested to verify all the certificates required and resubmit the proposals along with Part-II proforma information with specific recommendation and also attested copy of the acknowledgement slip to this office within (3) days without fail.
