Attention of the officers and User Agency noted in the address entry is invited to the reference 21st cited (copy enclosed) wherein it was informed that the Asst. Inspector General of Forests (Central) (i/c), GoI, MoEF&CC, RO Chennai vide reference 20<sup>th</sup> cited (copy enclosed) has informed that the REC in its 40<sup>th</sup> meeting held on 22.01.2020 has considered the subject proposal and after deliberation, Committee recommended the proposal for issue of Stage-I approval for an area of 4.2339 ha (6 M width and 7056.56 M length) against the proposed area of 8.5 ha by the User Agency, after receipt of the following documents/information:

- 1. The revised enumeration list for an area of 4.2339 ha
- 2. Revised CA area details like map with DGPS co-ordinates etc and CA Scheme as per the revised forest area to be diverted.

3. A wild life mitigation plan shall be got prepared in consultation with the  $\frac{1}{4}$ FO 

The above information is still awaited from the CCF, Ware gal, DF Jayashankar Bhupalapally and FDO, Bhupalapally. It is not known whether the Jayasnankar briugarapan, Chia Superintending Engineer (R&B) Regional Office, Warangal Urban and District R&B Officer, Mulugu have demarcated the revised road width on the ground for site inspection by officers of the forest department and joint inspection to prepare the

The Superintending Engineer (R&B) Regional Office, Warangal Urban and District R&B Officer, Mulugu are requested to furnish willingness on the REC Committee recommendation for issue of Stage-I approval for an area of 4.2339 ha (for 6 M width and 7056. 56 M length), if willing to revise the proposals, demarcate the revised alignment on the ground so that the DFO, JS Bhupalapally and FDO, Bhupalapally can furnish the above reports for onward submission to Government of India for considering the proposal for issual of Stage I clearance..

Hence, the District Forest Officer & Forest Divisional Officer, Bhupalapalli are requested to furnish the information on the above (3) points through CCF, Warangal with remarks and recommendation and also address the user agency to demarcate the revised alignment on the ground, within a week for onward submission to Government
